1 INSPECTIONS

1.1 Dates of inspection

The ONR site inspector made inspections on the following dates during the quarter:

- 20-22 October 2015
- 26-28 October 2015
- 13 November 2015
- 23 November 2015
- 30 November to 2 December 2015

2 ROUTINE MATTERS

2.1 Inspections

Inspections are undertaken as part of the process for monitoring compliance with:

- The conditions attached by ONR to the nuclear site licence granted under the Nuclear Installations Act 1965 (NIA65) (as amended);
- The Energy Act 2013;
- The Health and Safety at Work Act 1974 (HSWA74); and
- Regulations made under HSWA74, for example the Ionising Radiations Regulations 1999 (IRR99) and the Management of Health and Safety at Work Regulations 1999 (MHSWR99).

The inspections entail monitoring licensee's actions on the site in relation to incidents, operations, maintenance, projects, modifications, safety case changes and any other matters that may affect safety. The licensee is required to make and implement adequate arrangements under the conditions attached to the licence in order to ensure legal compliance. Inspections seek to judge both the adequacy of these arrangements and their implementation.

In this period, routine inspections of Oldbury covered the following:

- Restrictions on nuclear matter on the licensed site;
- Duly authorised and other suitably qualified and experienced persons;
- The decommissioning programme;
- Incidents on the site;
- Future changes to the site's emergency arrangements;
- Inspection of the fuel-free verification processes.

In general, ONR judged the arrangements made and implemented by the site in response to safety requirements to be adequate in the areas inspected. However, where improvements were considered necessary, the licensee made satisfactory commitments to address the issues, and the site inspector will monitor progress during future visits. Where necessary, ONR will take formal regulatory enforcement action to ensure that appropriate remedial measures are implemented to reasonably practicable timescales.

ONR also observed an Oldbury emergency preparedness exercise that used the arrangements proposed for when the site is demonstrated to be free of fuel. This was judged to be an adequate demonstration of the site's proposed future emergency arrangements.

2.2 Other work

There was no other work to report for this quarter.

3 NON-ROUTINE MATTERS

Licensees are required to have arrangements to respond to non-routine matters and events. ONR inspectors judge the adequacy of the licensee's response, including actions taken to implement any necessary improvements. Oldbury reported that a fuel element had been broken in the Reactor 1 desplitting machine. The site believed that procedures had not been followed and were investigating the circumstances.

4 REGULATORY ACTIVITY

ONR may issue formal documents to ensure compliance with regulatory requirements. Under nuclear site licence conditions, ONR issues regulatory documents, which either permit an activity or require some form of action to be taken; these are usually collectively termed 'Licence Instruments' (LIs), but can take other forms. In addition, inspectors may issue Enforcement Notices to secure improvements to safety.

- No LIs or Enforcement Notices were issued during the period.
- A letter was issued recognising that Reactor 1 and Reactor 2 were free of fuel.

5 NEWS FROM ONR

Chief Executive

Adrienne Kelbie has been appointed Chief Executive of ONR and will take up the appointment on 18 January 2016. Adrienne is currently the Chief Executive of the Disclosure and Barring Service, and prior to this has had a varied career including periods as Deputy Chief Executive in a local authority and as Director of Operations responsible for national and international funding at the Big Lottery Fund.

Chief Nuclear Inspector

ONR is currently recruiting for its Chief Nuclear Inspector. The Chief Nuclear Inspector has the key role in providing assurance on the effectiveness of the UK's nuclear regulatory system to the ONR Board, ministers, licensees and the British public and will represent ONR nationally and internationally. The closing date for applications was Sunday 17 January 2016 and the recruitment campaign has now progressed to the next stage.
